Quick Start

The following steps summarize the installation process. You will require a CD containing the Red Hat Enterprise Linux (RHEL) 5.5 software distribution.

1. Boot up the Quality Management (QM) installation CD on a new (bare) server with no operating system installed. Type 'install' at the prompt and press ENTER.
2. Insert the RHEL CD at the prompt and follow the steps to set up and install Red Hat Linux on the server. Remove the RHEL (and Quality Management) CDs before rebooting.
3. After booting Linux, enter the following default root username and password at the prompt:
username: **root**
password: **zoomcallrec**
4. Insert and mount the QM CD, change directory to it and enter the following command to install the Genesys Quality Management package:
yum -y install callrec-meta
5. Start the Quality Management setup tool as follows:
/opt/callrec/bin/callrec-setup
6. After completing setup, Quality Management will be configured and started.

Complete instructions regarding Genesys Quality Management installation are found in the Genesys Quality Management Installation Guide, which is supplied as part of the release documentation.

Preamble

If the software is modified by someone else and passed on, we want its recipients to know that what they have is not the original, so that any problems introduced by others will not reflect on the original authors' reputations.

Finally, any free program is threatened constantly by software patents. We wish to avoid the danger that redistributors of a free program will individually obtain patent licenses, in effect making the program proprietary. To prevent this, we have made it clear that any patent must be licensed for everyone's free use or not licensed at all.

The precise terms and conditions for copying, distribution and modification follow.

TERMS AND CONDITIONS FOR COPYING, DISTRIBUTION AND MODIFICATION

Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users.

This license, the Lesser General Public License, applies to some specially designated software packages--typically libraries--of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.
